

PUBLIC NOTICE - NONDISCRIMINATION COMPLIANCE

The Governing Board is committed to equal opportunity for all individuals in education. District programs and activities shall be free from unlawful discrimination (such as discriminatory harassment, intimidation, or bullying) based on the person's actual or perceived characteristics of race or ethnicity, color, ancestry, nationality, national origin, ethnic group identification, age, religion, marital, pregnancy, or parental status, physical or mental disability, sex, sexual orientation, gender, gender identity, gender expression, or genetic information, or any other characteristic. The Board shall promote programs which ensure that discriminatory practices are eliminated in all district programs and activities.

(BP 0410, Nondiscrimination in District Programs and Activities)

The Superintendent or designee shall provide multiple opportunities for members of the public to give input on district and school issues and operations. Community members are encouraged to become involved in school activities, participate on district and school committees, provide input at Board meetings, submit suggestions to district staff, and use the district's complaint procedures as appropriate.
